## Introduction

#### **Sainsbury Management Fellowships**

Funded by the Gatsby Charitable Foundation, Sainsbury Management Fellowships (SMF) support engineers with high career potential to undertake a full-time MBA course at one of nineteen leading national and international business schools.

The scheme has supported over 400 engineers. SMFs have an excellent track record in securing senior management and leadership roles in UK industry and have made a major contribution to the UK's economic prosperity.

## Eligibility criteria

## Applications can be submitted any time, either with or without a confirmed place.

- Applicants must be UK nationals, currently living in the UK.
- Candidates must have achieved a GMAT score of at least 650 before applying for this scholarship.
- Applicants must have a first degree in an engineering, allied technology or science discipline, preferably a first or upper second class.
- Applicants do not need to have Chartered Engineer status (or equivalent); however, this qualification or progress towards it will be viewed favourably.
- Applicants would usually have four to ten years' experience, post degree.

#### We are looking for individuals who can demonstrate the following:

- Leadership and interpersonal skills
- A strong commitment to UK engineering and business
- · Already demonstrated leadership at a within a work setting
- The potential to become a future senior manager/leader of UK industry and business
- The potential to make a major contribution to the UK's economic prosperity
- Understanding of how the MBA programme will enhance and accelerate their career
- The ability to be a role model and ambassador for SMF.

Applicants who have previously applied and were invited for interview are not eligible to reapply.

Applicants who have previously applied and were not invited for interview may reapply after two years.

## **Awarding Process**

#### Shortlisted applicants will be invited to an interview.

- Applicants who already have a confirmed place at an approved business school will receive a 'letter of offer'. The award will be paid directly to you upon submission to us of your confirmed place at an approved business school. If you have already paid the full tuition fee to the business school, the Academy will pay you your award against a paid invoice receipt from the business school (on letterhead). Conversely, if you have not yet paid your tuition fee to the business school, then the Academy will pay you your award once you have enrolled to business school and can demonstrate this with a proof of enrollment document, dated after the official start date of the course.
- •Applicants without a confirmed place at an approved business school will be given an 'offer in principle,' which must be taken up within 12 months i.e. you would need to demonstrate a confirmed school place within 12 months of the offer in principle being made, otherwise the offer expires. Following your offer in principle, you will be connected with an SMF alumni via ESBF, who will offer mentoring and application support. You will then be able to apply to your chosen business school or schools from the approved list with confidence of receiving the SMF award if accepted.



## How to apply

#### Create an account

All applications must be submitted via the Academy's online grant management system (GMS) available at <a href="https://grants.raeng.org.uk">https://grants.raeng.org.uk</a> All applicants must first register with the online system and create a profile.

The Royal Academy of Engineering is committed to diversity and inclusion and welcomes applications from all underrepresented groups across engineering. It is the Academy's policy to ensure that no applicant is disadvantaged or receives less favourable treatment because of age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, or sexual orientation.

Before you commence your application, you will be asked a few diversity monitoring questions to help the Academy monitor and assess our diversity and inclusion policy. It will only be used for statistical purposes with access restricted to staff involved in processing and monitoring the data. No information will be published or used in any way that identifies individuals. The Academy will retain personal information as per our **Data Retention Policy** in line with the General Data Protection Regulations 2018.

The information will be treated as strictly confidential, nonattributable and will not be seen by anyone involved in any selection processes. You will need to complete the diversity monitoring section before you can see the grant application form, but can choose "prefer not to say" as responses.

The application form has five sections and should take between one hour and one day to complete, depending on whether the applicant has already considered the questions prior to applying. A summary of the guidance notes is embedded within the system itself. However, the guidance given below may be more detailed so we recommend you keep this document to hand.

The written questions have word limits, which are designed to keep your answers focused and to give you an indication of the level of detail we require.

Applicants can download a PDF of their applications after submission. There is only one application stage and those meeting the eligibility criteria will enter the initial review stage.

#### **National Security**

The Academy is the UK's National Academy for engineering and technology and seeks to increase the potential positive benefit that innovations can have for society, whilst reducing the risks of harm. Hence, in all our activities, we seek to minimise the risk that technology developed as part of work that we support could be misused by a foreign state to build a capacity to target UK interests in a hostile fashion or to control or repress their population. There is a risk that for some grant activities, failure to protect IP and a lack of due diligence into collaborators could result in sensitive technology being transferred to and misused by a hostile or repressive foreign state. As such all applicants should ensure they are familiar with the Academy's **Policy on National Security-Related Risks.** 

#### Use of generative AI tools in funding applications and assessment

The Academy has aligned with other UK funders around the use of generative AI tools in funding applications through the Research Funders Policy Group **joint statement**. Regarding the use of AI, applicants are fully responsible for all the content presented in their grant applications. The grant process does not penalise the use of generative AI tools, but it is imperative to ensure that the application reflects the applicant's own voice and ideas. It is not acceptable to solely rely on generative AI tools to write the entire grant application from start to finish. While these tools may be used to assist in various aspects, the application must primarily represent the applicant's own work. Applicants must provide clear acknowledgement if they have used generative AI tools in the process of writing their grant applications. This includes disclosing the name of the tool used and describing how it was utilised. The following style should be employed for referencing:

I acknowledge the use of [insert AI system(s), version number and link] to generate materials for background research, styling, proofreading, etc.

Or,

I acknowledge the use of [insert AI system(s), version number and link] to generate materials that were included within my final assessment in modified form.

#### **Grant Terms and Conditions**

## Completing the application form

After registering and logging in to the GMS, select the 'RAENG Portal' tab on the top lefthand side of your screen. Here you will be presented with a list of all Academy schemes that are currently accepting applications.

Find the SMFs scheme and click on 'Start an application'; here you should be presented with the 'Instructions' screen, where you will see general instructions on how to use the system, and links to the five sections of the application form given below:



You can save your work at any stage in the application process and return to it later. You can answer the questions in any order you like so you may freely skip some sections to return to later. It is therefore worth viewing the application early on for an indication of what is required.

Also, you should ensure that you have all the necessary documentation when you start completing the application, such as a copy of your CV and letters of support.

#### **Section 1: Applicant details**

#### **Q** - Applicant details

Provide your name and contact details including postal address and a telephone number. Some of your details will be automatically generated, as you provided these at registration.

#### Q - Are you a UK national, currently living in the UK?

By ticking this box you confirm that you are.

#### Q - Please upload a copy of your passport

Please upload, as a PDF, a copy of your passport personal details and photo page plus the front cover of your passport.

#### Q - Please upload a utility bill from the last three months.

Please upload a utility bill from the last three months. This must contain the name and address you provided at the start of your application for this scholarship. This is to confirm you are currently living in the UK.

#### Q - To be eligible for this scholarship, you must have taken the GMAT exam, and achieved a score of 650 or above.

Please upload proof of your score, which can be a screenshot, or an email confirmation. Your proof of score must contain your full name.

#### Q -There are two Sainsbury Management Fellowship (SMF) scholarships. One scholarship is for Scientists, and this scholarship is for Engineers.

Please tick the following box, to confirm that you are applying for the Engineer SMF scholarship, and have not applied for the Scientist SMF scholarship.

#### Q - Please upload a copy of your CV

Your CV should not be more than three pages long, and should highlight your career history, in particular engineering-specific activities and educational qualifications.

#### Q - Referee details

Please provide the names, company, position, and contact details (email and telephone) of two referees who can be contacted prior to interview. We may not contact referees and will seek permission before we do so.

#### **Q** - Engineering Sector

Select the broad engineering category that best describes your area

#### Q - Professional engineering institution (PEI) membership

List PEI membership both in the UK and overseas

#### Q - Level of PEI membership

State the level of your membership with the PEIs selected in the previous question (for example, Chartered Engineer, Associate, Student). If you are currently working towards Chartered Engineer (or equivalent) status, please indicate this here.

#### Q - Do either of your parents hold a university degree?

Your answer to this question will not affect your eligibility

#### Q - At any point in your education, did you attend a fee paying school?

Your answer to this question will not affect your eligibility.

- Q Do you already have a confirmed place at an approved business school?
- Q If yes, please select the business school you have an offer with from the drop-down list.
- Q If you do not have an offer, please list the business school(s) you are hoping to study at. If unknown, please leave this question blank.
- Q If you have a confirmed place, what is your MBA start date?
- Q If you do not have an offer, when are you hoping to start your MBA

Please note that you will need to demonstrate a confirmed business school place within 12 months of the offer in principle being made.

#### O - Duration of MBA.

In years and months please confirm the duration of the MBA you will enrol / hope to enrol onto.

## Q - Please confirm the total value of the tuition fees for the MBA you will enrol / hope to enrol onto, and how you plan to pay them.

Include here any other scholarships, employer contributions, own funds etc., you will be using to pay the tuition fees. Please note, this information will not affect your eligibility for the scholarship.

- Include contact details of the writer
- Confirm your admission to their full-time MBA programme
- Have the date your full-time MBA programme started/will start.

#### **Q** - Application declaration

- the ideas presented are my own and not plagiarised or containing IP that is not owned by myself
- all contributions have been appropriately referenced or credited including the use of any online tools such as AI generative tools used in developing my application

## Assessment

Applications will be reviewed and assessed by a Selection Panel comprising of Academy Fellows and SMFs, who will select candidates for interview.

Please note that only applicants who can attend an interview will be eligible for an award.

In assessing the applications, the panel will consider the following criteria as well as the extent to which the application aligns with the aims and objectives of the award:

- The applicant's leadership and interpersonal skills
- The applicant's commitment to UK engineering and business
- The applicant's potential to become a future senior manager/leader of UK industry
- The applicant's potential to make a major contribution to the nation's economic prosperity
- The extent that the MBA programme will enhance and accelerate the applicant's career
- The applicant's potential to be a role model/ambassador for SMF

#### **Interviews**

For this round, interviews will last for 45 minutes and will be conducted by a panel of three to four interviewers.

The interviewers will be Academy Fellows and SMF alumni. Interviews will take place, in person, at the Academy.
