## 1. Introduction to the Academy

The [Royal Academy of Engineering](#) (the Academy) is a charity delivering public benefit, a National Academy providing progressive leadership, and a Fellowship bringing together an unrivalled community of leaders from every part of engineering and technology. Our Patron is His Majesty King Charles III.

The Academy's Strategy 2030, "[Engineering Better Lives](#)," sets out a vision to unite a community of outstanding experts and innovators in engineering to drive positive societal impact. The strategy is built around three core goals: a sustainable and innovative economy, technology improving lives, and an engineering community fit for the future. The Academy's grant programmes support these strategic goals by investing in people, partnerships, and projects that advance engineering excellence, foster inclusion and diversity, and deliver meaningful societal impact in alignment with the Academy's vision and values.

## 2. Ministry of Housing, Communities and Local Government

The Fire Engineering Scholarship Programme is being funded by [The Ministry of Housing, Communities and Local Government](#) (MHCLG) to increase the number of fire engineers and the availability of fire engineering education across the UK.

## 3. Programme Overview

Following the Grenfell Tower tragedy, the Grenfell Tower Inquiry highlighted the need to improve capacity and skills in the fire engineering sector.

The Inquiry recommended the creation of a panel which produced an Authoritative Statement in Dec 2025: [Fire Engineers Advisory Panel: Authoritative Statement - GOV.UK](#). This led to the identification of [Next steps on fire engineering profession reform](#) - GOV.UK which highlighted the need to:

- develop higher education provision
- provide scholarships for prospective entrants
- support research and academic capacity

The UK Government have set up a £70m Building Workforce programme to increase capacity and capability of safety-critical professions: [£70m funding to address building safety professional shortages - GOV.UK](#), of which £13m is dedicated to fire engineering education. It has also committed to regulating the fire engineering profession.

To help increase capacity and support the development of the next generation of fire engineering practitioners, researchers and innovators, the Fire Engineering Scholarship Programme (FESP) will provide eligible UK Higher Education Institutions (HEIs) with funding for the provision of full and part-time MSc scholarships in fire engineering for UK students to cover tuition fees and living costs. The programme will also provide funds to HEIs to support both a promotion and a marketing campaign for the scholarships, as well as an awareness raising campaign to support new entrants into the profession or engineers looking to upskill or reskill. This will help to increase the number of professionals in this safety-critical area of the built environment and boost economic growth in the UK through their contribution to building construction and remediation.

Strengthening of the fire engineering profession cannot be done without a strong fire engineering higher education sector offering innovative programmes of study, which are research-informed and up to date. These programmes are needed to upskill existing practitioners in fire engineering and related professions but also recruit new entrants into the profession.

HEIs can apply to the Academy's Fire Engineering Scholarship Programme for grants for the activities listed below. An indication of what would be deemed eligible and ineligible spend against each strand is also given.

HEIs can apply to the Engineering and Physical Sciences Research Council (EPSRC) for:

- a doctoral training programme to support the next generation of researchers in fire engineering through a cohort based, highly tailored training programme
- the development of taught postgraduate (level 7 or equivalent) development programmes for the fire engineering community with innovative modes of study to cater for a range of audiences
- the development of level 7 or equivalent fire engineering continuing professional development training for the wider fire engineering community and adjacent professions wishing to upskill or re-train into fire engineering

## 5. Eligibility criteria

Only representatives of UK HEIs can submit a grant application. This is **not** a programme for individual scholarship applications.

If you are from a **non-UK HEI**, or you are an **individual**, you are **not eligible** for the scheme. Please do not proceed with an application as it will not be assessed.

Applications will be accepted from single HEIs or from the lead HEI representative where a consortium application is submitted. The consortium lead may also apply as a single HEI, and single HEIs may submit their own application and be a collaborating HEI within any number of consortium applications.

Identification of the consortium lead should not be interpreted as recognition as the dominant partner or where the majority of scholarships will be provided.

## 6. Timeline and deadlines

The application round opens on **Thursday 27 August 2026**.

Two application support webinars will be held on

- **Wednesday 16 September 2026 from 2:00pm-3:30pm**, and
- **Tuesday 29 September 2026 from 10:00am-11:30am**.

These webinars will be held jointly between the Academy and EPSRC, with a representative from MHCLG present. A link to register to attend one or both of these sessions is [here](#). Upon registering, a link to the webinar will be sent via email.

The application round closes on **Tuesday 03 November 2026 at 4.00pm**.

The application review period will run from **Friday 06 November – Thursday 10 December 2026**.

Award winners will be notified **w/c 14 December 2026**.

## 7. How to apply

All applications must be submitted via the Academy's online grants system available here: <https://grants.raeng.org.uk>

All applicants must first register and provide some basic login details to create a profile. Please note, it may take around 10 minutes before you can log in after registering. Please ensure that you have registered for an account at least one week prior to the deadline to make sure you can access the system. After that date, any potential access issues may not be rectified in time for the submission deadline, which is 4pm on Tuesday 3<sup>rd</sup> November 2026.

The application should be submitted by the applicant. We recommend leaving plenty of time to complete the application form ahead of the deadline and thoroughly going through your application prior to submission. While the guidance notes are embedded within the system itself, we recommend you keep this document to hand when completing the application form. Many of the questions have prescribed word limits

which are designed to keep your answers focused and indicate the level of detail we require. In such cases, the number of words you have used will be displayed beneath the question and updated in real time.

The application form has seven sections in addition to an opening general information section and should take about 3-4 hours to complete (off line) and approx. 82 minutes (online) to copy and paste answers, complete tables, and carry out final checks prior to submission. ## **8. Relevant policies and statements**

### **Diversity and Inclusion**

The Royal Academy of Engineering is committed to diversity and inclusion and welcomes applications from all underrepresented groups across engineering. It is the Academy's [policy](#) to ensure that no applicant is disadvantaged or receives less favourable treatment because of age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, or sexual orientation.

Before you commence your application, you will be asked a few diversity monitoring questions to help the Academy monitor and assess our diversity and inclusion policy. It will only be used for statistical purposes with access restricted to staff involved in processing and monitoring the data. No information will be published or used in any way that identifies individuals. The Academy will retain personal information as per our [Data Retention Policy](#) in line with the General Data Protection Regulations 2018.

The information will be treated as strictly confidential, nonattributable and will not be seen by anyone involved in any selection processes. You will need to complete the diversity monitoring section before you can submit the grant application form but can choose “prefer not to say” as responses.

## National Security

The Academy is the UK's National Academy for engineering and technology and seeks to increase the potential positive benefit that innovations can have for society, whilst reducing the risks of harm. Hence, in all our activities, we seek to minimise the risk that technology developed as part of work that we support could be misused by a foreign state to build a capacity to target UK interests in a hostile fashion or to control or repress their population. There is a risk that for some grant activities, failure to protect IP and a lack of due diligence into collaborators could result in sensitive technology being transferred to and misused by a hostile or repressive foreign state. ## Use of generative AI tools in funding applications and assessment

The Academy has aligned with other UK funders around the use of generative AI tools in funding applications through the Research Funders Policy Group [joint statement](#).

Regarding the use of AI, applicants are fully responsible for all the content presented in their grant applications. The grant process does not penalise the use of generative AI tools, but it is imperative to ensure that the application reflects the applicant's own voice and ideas. It is not acceptable to solely rely on generative AI tools to write the entire grant application from start to finish. While these tools may be used to assist in various aspects, the application must primarily represent the applicant's own work.

Applicants must provide clear acknowledgement if they have used generative AI tools in the process of writing their grant applications. This includes disclosing the name of the tool used and describing how it was utilized. The following style should be employed for referencing:

I acknowledge the use of [insert AI system(s), version number and link] to generate materials for background research, styling, proofreading, etc.

Or,

I acknowledge the use of [insert AI system(s), version number and link] to generate materials that were included within my final assessment in modified form.

## 9. Application form

### Completing the Application Form

During the application process, you have the flexibility to save your progress at any stage and return to the form whenever needed. This allows you to answer questions in any order, and if you prefer, you may skip certain sections and revisit them later.

It is advisable to familiarise yourself with the application steps early in the application process to gain a clear understanding of what is required.

You should also ensure that you have any necessary documentation to hand when you start completing the application.

You may also choose to copy and paste the questions into a document to work on off-line and log back onto the system to upload your answers once complete.

After logging into the online grants system <https://grants.raeng.org.uk> and selecting Fire Engineering Scholarship Programme in the 'Start application' section, you will be presented with the 'Instructions' screen.

Here you will see some general instructions on how to use the system, as well as links to each of the sections of the application form given below:

## General Information

When you start an application, the system will automatically pull through the name and contact details provided when you registered on the system.

### **Are you applying as a single HEI or as the lead HEI of a consortium?**

Please select whichever applies.

If the lead HEI of a consortium is selected, the lead HEI will be asked to:

- *provide a consortium name*
- *provide the names of the other HEIs that are part of the consortium*
- *in no more than 400 words, describe how the consortium intends to work together collaboratively over the course of the funding period and detail the consortium governance mechanisms that have been worked through as part of preparation for this funding submission.*

All applicants will be required to answer the following, irrespective of whether this is a single HEI submission or a consortium submission:

**Name of your Higher Education Institution:** Please enter the full legal name of your HEI that would be used as part of the contract. If this is a consortium application, then the name of the lead HEI should be entered here.

**Name of Department:** Please enter the name of the department of which the applicant represents.

**Job Role:** Please state your job role/title.

**Are you applying to the *Focal Award: EPSRC and MHCLG Fire Engineering Skills Hub* fund to develop the same MSc programme for which you are also applying to this Fire Engineering Scholarship Programme?** Select yes or no.

**What is the proposed start date and end date for the funding?** Please add the start and end date of the funding period, noting that all grant expenditure and activities must occur within these dates. This can be updated after submission if required.

## Section A – Programme Alignment

Funding is available to support MSc programme(s) in fire engineering which align with the [Fire Engineers Advisory Panel's Authoritative Statement](#) of the knowledge and skills to be expected of a competent fire engineer.

The Selection Panel will be looking for applicants to demonstrate the following in their response to this question:

- Clear alignment between the MSc curriculum and the expectations set out in the Fire Engineers Advisory Panel's Authoritative Statement, including the knowledge, skills, behaviours and ethical standards expected of a competent fire engineer;
- Specialist fire engineering teaching capacity with recognition given to government's commitment that the fire safety strategy is the central, protected function of the profession;
- Emphasis on the ethical practice fundamental to ensuring life safety;
- Demonstrable fire engineering research capability sufficient to support research-led teaching, dissertation supervision, and engagement with emerging fire safety challenges, including the ability to contribute to the future development of the profession;
- Assessment of students' ability to apply fire engineering knowledge to realistic design, risk and regulatory scenarios;
- Evidence that students develop skills necessary to work effectively within multidisciplinary design, construction and regulatory environments;
- Clear routes towards accreditation or professional recognition;
- Meaningful links with industry, professional bodies, and the fire sector;

- Evidence that provision will widen access across geography, career stage (including accessibility for those in work), and student background.

**A3 - In no more than 300 words, please explain how the proposed MSc provision will remain sustainable beyond the period of funding, including future student demand, institutional commitment, maintenance of specialist expertise and, where relevant, academic workforce development. The Selection Panel will be looking for applicants to demonstrate the following in their response to this question:

- evidence of expected future student demand and recruitment strategies beyond the funding period;
- institutional commitment to continued delivery of the programme, including financial or strategic support from the university;
- plans to maintain and strengthen specialist fire engineering expertise within the institution;
- approaches to succession planning where programmes rely on a small number of key staff;
- development of early-career researchers, doctoral students or future academic leaders in fire engineering;
- collaboration with other universities, research centres, industry partners or professional bodies to sustain capability and resilience;
- plans to embed programme content, teaching resources or partnerships into longer-term institutional arrangements;
- how the proposed activity will contribute to the long-term capacity and capability of UK fire engineering education and research.

## Section B – Student Support and Safeguarding

- A coherent support ecosystem where tutors, programme teams, professional services, careers staff, and student peers work together, using early engagement data and regular check-ins to identify issues quickly and connect students to the right support before problems escalate.

Applications will be reviewed and assessed by a Selection Panel of up to seven individuals, including experts in fire engineering from both industry and academia, who will make the decision on who to award.

Each application will be reviewed by three individuals, and the panel will meet to review applications and make their final awarding decisions. No panellist will review an application where a conflict of interest has been declared. The Panel will meet in early December to deliberate and make final decisions on who to award.

The Selection Panel will review and provide a score for all sections of the application (Sections A-F) and Section 9 above provides some indication of what they will be looking for applicants to demonstrate in their responses to some questions. An indication isn't provided for all sections, in particular Sections D-F, as the Selection Panel will be looking for HEI's to demonstrate creativity and innovation in their planned activities, and they will assess the extent to which the application aligns with the aims and objectives of the award and delivers value for money.

The Academy will not be holding interviews for the Fire Engineering Scholarship Programme.

All applicants will be notified whether their application has been successful during w/c 14 December 2026. After this we will move to the agreement stage, and we will work with each successful HEI on the final schedule of works, the phasing of payments, and the monitoring and reporting schedules.
