This global community brings together awardees from all career stages and disciplines to share their expertise, to collaborate and to contribute new perspectives to the Academy's work.

We want to build a powerful, vibrant, connected, and diverse global community of engineering leaders, who support and inspire each other, and who work with the Academy to change the world for the better.

In collaboration with our Fellows and partners, we're growing talent and developing skills for the future, driving innovation and building global partnerships, and influencing policy and engaging the public. Together we're working to solve the greatest challenges of our age.

Awardee Excellence Community inaugural event

On 25 May 2023, we held a series of events to bring together members of the Community in the UK to network, collaborate and contribute to the work of the Academy for the first time. We wanted to build deeper, more productive relationships between awardees, delivering personal and professional benefit while also supporting the Academy's work.

Delegates shared their engineering expertise to discuss and problem-solve current and future global challenges. The chosen themes were relevant to the Academy's work and our overarching goal to harnesses the power of engineering to build a sustainable society and an inclusive economy that works for everyone. Event themes were:

- How can we embed the principles of a circular economy into our practice?
- What does the electricity grid of 2050 need to look like?
- How can the Academy support engineers in overcoming barriers to entrepreneurship?
- What role should the Academy play in supporting engineers in preparing our lines of defence for the next pandemic?
- How can we engineer clean, sustainable water systems in an age of climate disruption?

Awardee Excellence Community international events

Scheme overview

We are asking awardees from our global programmes to host events that connect Royal Academy of Engineering awardees and engineers in their local community. The events will allow participants to collaborate and use their engineering knowledge. This might be an opportunity to further develop the work that you have already started as part of your existing or previous award or an opportunity to bring together engineers and awardees to discuss a new idea, issue or project.

We will provide up to £5,000 of funding for approximately 16 events, which will be awarded based on planned engagement with local and regional stakeholders. This is in line with the Awardee Excellence Community's vision to create a powerful, vibrant, connected, and diverse community of engineering leaders, who support and inspire each other, and who work with the Academy to change the world for the better. Events should also address the Academy's strategic goal to harness the power of engineering to build a sustainable society and an inclusive economy that works for everyone.

The structure and design of the events will be flexible, so that applicants can design and curate an event around their capacity that will bring together and engage members of the Awardee Excellence Community and the local and regional engineering community.

Event attendees could include:

- young engineers
- entrepreneurs
- innovators
- industry
- academics
- professional engineering bodies
- civil society
- government
- NGOs
- policymakers.

They should create or strengthen a regional network of awardees and stakeholders to address the complex challenges the world faces.

Successful applicants will be required to create a profile including a short biography and photo in the Awardee Excellence Community directory on the Royal Academy of Engineering's website. More guidance will be provided on receipt of the award.

Event support from the Academy

- Recordings of UK keynote sessions and talks: videos can be found on our website
- International Fellows: if you identify specific Academy Fellows in your region, the Academy will support you in inviting and engaging with them to participate in your event.
- **Branding/marketing:** your event materials should use the Awardee Excellence branding. Engineering X awardees will also need to use the Engineering X branding. The Academy will provide a communications toolkit to ensure your event stands out.
- Amplifying reach: where appropriate, the Academy may be able to support your event through engagement with the Awardee Excellence Community and other local partners.

Example event structure and themes

The Academy encourages applicants to design an event that they feel will best represent their community. It should reflect the overarching theme of harnessing the power of engineering to build a sustainable society and an inclusive economy that works for everyone. Events should encourage networking and collaboration.

Below are a few suggestions of possible formats:

- Panel discussions: hosting a series of debates, discussions and panel discussions centred around key themes.
- Conference style: including speakers, presentations and breakout sessions.
- Workshops: hosting a series of workshops and discussions around key themes, issues or problems.

Applicants are encouraged to choose a theme for their event that is relevant to their local community. The following themes are suggestions only.

- How can we embed the principles of a circular economy into our practice?
- What does the electricity grid of 2050 need to look like?
- How can the Academy support engineers in overcoming barriers to entrepreneurship?
- What role should the Academy play in supporting engineers in preparing our lines of defence for the next pandemic?
- How can we engineer clean, sustainable water systems in an age of climate disruption?
- What are systems approaches and how are they useful to understand, define and create solutions to tackle wicked problems?
- How is collective impact relevant to addressing global challenges?

Eligibility

This is an invitation only call for applications. Awardees from the following schemes are invited to apply:

In addition:

- Applicants can only submit one application.
- The applicant must showcase sufficient capacity and experience to organise and run an event.
- The applicant must outline how the event will benefit the local engineering community, and any plans to build on the event with future activities or events.
- For awardees of Engineering X Safer Complex Systems and Transforming Systems through Partnership, your event must include elements of systems approaches and champion how they have the power to enable change.

Please provide a detailed plan on the audience that will be engaged through this event. Please include specific groups, institutions and partners that will be participating in the event. You will have 400 words to answer this question.

Event impact

Please provide a detailed explanation of the impact that this event will have on your local community, and how you will build on this event to ensure lasting changes for your organisation and local community. You will have 400 words to answer this question.

Event risks

Please provide a risk register outlining the steps taken to mitigate any potential risk in hosting the proposed event.

GANTT Chart or project activity timeline

Please upload a detailed GANTT chart or project timeline outlining your agreed work programme, including a breakdown of milestones, activities, indicators and target dates for specific elements of the project and the cost breakdown associated with each stage.

Breakdown of funding requested

Please outline the total costs of your event programme and clearly show the support you are requesting from the Academy. Costs incurred prior to the grant award being made cannot be reimbursed. Please see our FAQs for eligible costs.

Additional funding

Please provide details of any additional funding or in-kind contribution that will be provided by you/your organisation/third parties in support of this event. Please indicate whether funds have been applied for or are already secured.

4. Letters of support and declaration

Letter of support

Proof of track record

Applicant's declaration

Once you are satisfied with the application that you have submitted, please sign your name and position, and tick the checkbox that states you are satisfied with the conditions of this scheme.

Assessment process

- 1 Your application will first undergo an eligibility check as outlined above.
- 2 If selected as eligible, your application will be reviewed by representatives of the Awardee Excellence Community and international programmes teams.
- 3 The successful applicants will be notified by email from the Royal Academy of Engineering.
- 4 Once confirmed, a contractual agreement will be signed between the Royal Academy of Engineering and the successful applicant.
- 5 The funding will then be released as agreed.
- 6 Any unsuccessful applicants will be informed of the decision made.

Monitoring

Successful applicants will be required to submit a report and expenditure statement following their event summarising their event and demonstrating its impact. Any unspent funds will need to be returned to the Academy.
